Mobile Banking.

HUF DECLARATION

2. The Customer ID and the IPIN (password) /Mobile Banking password shall be kept totally secret and confidential by me.
3. All transactions carried on in the said account through use of the NetBanking /Mobile Banking facility shall be binding on all the members of the HUF and I shall keep Dhanlaxmi Bank saved and harmless from all actions, claims, demands, proceedings, losses, damages, costs, charges and expenses whatsoever with Dhanlaxmi Bank may at any time incur, suffer or sustain to be put to as a consequence of or by reason of or arising out of transactions carried out through the NetBanking /Mobile Banking facility.
