Terms & Conditions

Note: The term "I/my/our/us" refers to the customer, the term "Bank" refers to Dhanlaxmi Bank Ltd and the term "Facility" refers to Retail Internet Banking Facility.

1. I undertake to maintain my/our Personal Identification Number (PIN) as confidential in my/our own interest and security of information of my/our account. I also undertake to change the PIN periodically.
2. I shall make use of the facility for the ease of transacting and not for commercial gains.
3. I also understand that this facility provided to me is not transferable.
4. I understand that the bank will not be responsible for the transactions carried out in my account using the facility on account of misuse of PIN or otherwise.
